

The following contest is intended solely for residents of the continental United States and Canada (with the exception of Québec, Florida and Maryland) and shall be construed and evaluated according to continental United States and Canadian laws. You may not participate in this contest if you are not a legal resident of the continental United States or Canada, or if you are a resident of Québec, Florida or Maryland at the time of entry.

Also void in Québec, Florida and Maryland and where prohibited by law.
Entrants residing in areas where the contest is void are ineligible to win prizes.
Only one entry per valid email address.

1. Prize Eligibility

The contest is open to all Canadian and continental U.S. residents (with the exception of Québec, Florida and Maryland residents) who have reached the age of majority in their province, territory or state of residence at the time they enter the contest.

Le Québec maritime, its employees as well as employees of its parent companies, promotional and advertising agencies, sales representatives, distributors, agents, subsidiaries and affiliated corporations (hereinafter referred to collectively as the “Promotional Parties”), as well as the household and family members of each of the above are not eligible to participate in this contest.

2. Registration

The “Win a Dream Snowmobile Vacation for 4” contest runs online from November 12, 2021, at 9 a.m. (Eastern Standard Time), to April 3, 2022, at 11:59 p.m. (Eastern Daylight Savings Time). Participants must complete the registration form available on the Le Québec maritime campaign website at www.quebecmaritime.ca/en/snowmobile by entering their first name, last name, mailing address, country, telephone number and email address as well as their choice of trip from the two options available. Entrants must fill out all mandatory fields to be eligible to win. Entries can be submitted as of November 12, 2021, at 9 a.m. (EST), and must be received by April 3, 2022, at 11:59 p.m. (EDT) in order to be included in the draw. Participants may only submit one entry per valid email address.

Le Québec maritime

Le Québec maritime (hereinafter also referred to as the “Sponsor”) is offering this trip from January 1 to March 31, 2023, subject to blackout dates and availability.

Each itinerary will be supplied by Le Québec maritime and is subject to change at the Sponsor’s discretion. Transportation to the departure point and from the end point of each itinerary is at the winners and guests’ expense. Rooms are based on double occupancy. Winners and their guests must travel on the same itinerary, departing and returning together. Once the contest winners have confirmed their travel dates and accommodations have been booked, no changes will be permitted. The contest winners and their guests must sign liability waivers prior to trip departure. By entering the contest, entrants consent to the use of their names for publicity purposes without compensation.

About the prizes

Winners and their guests will be responsible for all expenses not specifically described above as included in the prizes. Not included in the prizes: air or ground transportation to the departure point and from the end point of each itinerary; car, snowmobile and/or equipment rentals, if required; gas; admission fees for snowmobile trails; all lunches (only breakfasts and dinners are included in the prizes); taxes, gratuities and any personal expenses, surcharges, insurance premiums or other fees. The Sponsor will be responsible for booking all accommodations for the winners and their guests, subject to blackout dates and availability. Guests cannot be changed once the Sponsor has received the guests’ Declaration and Release forms. Winners and their guests must have valid documents for travel in Canada as well as [any documents required during the pandemic in Québec](#). A prize will be forfeited if: a) the proper travel documents are unobtainable for any reason within the time required by the Sponsor; b) a winner is unable or unwilling to travel on the dates required; or c) any other complications arise that prevent a winner and/or their guests from taking the trip. If a winner cancels the trip or is unable to travel on the agreed-upon dates, they will be responsible for paying any cancellation fees that may apply. A forfeited prize may be awarded to an alternate entrant, at the Sponsor’s discretion.

4. Draw

Two random electronic draws will take place on April 4, 2022, at 9 a.m. (Eastern Daylight Savings Time), at the Sponsor’s office in Rimouski, Québec, Canada. The two winning entries will be drawn from all eligible entries received during the contest period.

5. Prize Substitution

Prizes must be accepted as awarded. **No substitution of prize is permitted except by Le Québec maritime at its sole discretion. Le Québec maritime reserves the right to substitute a prize with another prize of equal or greater value. Prizes are non-transferable and are not redeemable for cash or credit, in whole or in part.**

6. Winner Notification and Prize Claim Process

The prizewinners will be notified by phone and/or email **only** within two (2) business days of the draw date using the phone numbers and/or email addresses indicated on their Registration Forms. If a winner does not claim their prize within ten (10) business days of being notified, an alternate winner will be selected according to the rules from all remaining eligible entries received. Prizes will only be delivered to the officially designated winners. The names of the winners will be posted on the Le Québec maritime website at <https://www.quebecmaritime.ca/en/snowmobile> from the date of confirmation of their identities until the end of the promotional campaign. Accordingly, the winners must consent to the public use of their names and cities of residence on the Le Québec maritime website.

7. Conditions

Before being officially declared winners, the selected entrants must sign a Declaration of Compliance with the Official Contest Rules and Regulations and a Release of Liability (hereinafter referred to collectively as the "Declaration and Release Documents"), releasing Le Québec maritime, its advertising and promotional agencies, the prize suppliers, parent companies, subsidiaries, affiliates, representatives and agents of the foregoing and all of their respective directors, officers, owners, partners, employees, consultants, agents, representatives, successors and assignees (hereinafter referred to collectively as the "Releasees") from any liability in connection with this contest or the prizes. The Declaration and Release Documents will be sent to the selected entrants with their notifications and must be returned within seven (7) business days of the date indicated on the documents or the prize will be forfeited. Once the signed Declaration and Release Documents have been received by the Sponsor, the prize will then be awarded to the winner.

In the event that a prizewinner is unable to redeem any or all of the prize components for reasons beyond the control of the Sponsor and the prize suppliers, no compensation or substitutions will be provided. All federal, provincial and municipal laws and regulations apply. Any contest entries not complying with any applicable federal, provincial or municipal laws or regulations will be considered null and void. All decisions made by Le Québec maritime are final and binding in all matters relating to this contest.

9. Important Information

Entrants will be deemed to be the authorized account holder of the email address they submitted on the Registration Form at the time of registration. The "authorized account holder" is the natural person to whom an email address is assigned by an Internet access provider, online service provider or other organization (e.g., business, educational institution, etc.) responsible for assigning individual email addresses for the domain associated with the submitted email address.

All entries become the property of Le Québec maritime and will not be returned to entrants. The selected winners may be requested to provide Le Québec maritime with proof that they are the authorized account holder of the email address associated with their winning entry.

10. Conduct

By entering the contest, participants agree to be bound by the Official Contest Rules and Regulations. Entrants who have not complied with these rules and regulations are subject to disqualification. Entrants further agree to be bound by the decisions of Le Québec maritime, which shall be final and binding in all respects. Le Québec maritime reserves the right, at its sole discretion, to disqualify any individual it finds to be (i) tampering with the entry process or the operation of the contest or website; or (ii) acting in violation of the Official Contest Rules and Regulations. Participants agree to not knowingly: (i) interfere in or cause any interruption of the contest; (ii) prevent others from participating in the contest; or (iii) obtain or modify another user's non-public account information without their consent. Any use of automated devices is prohibited. Le Québec maritime reserves the right to cancel or modify the contest in whole or in part in the event of technical or other difficulties.

11. Caution

Any attempt by an entrant or any other person to deliberately damage any website or undermine the legitimate operation of the contest is a violation of criminal and civil laws. Should such an attempt be made, Le Québec maritime reserves the right to claim damages from any such person to the fullest extent permitted by law.

Le Québec maritime reserves the right, at its sole discretion, to disqualify any person tampering with the entry process or the operation of the website, or who is otherwise in violation of the Official Contest Rules and Regulations. It further reserves the right to modify, terminate or cancel any contest that it is unable to complete as planned, including due to a computer virus, bugs, tampering, unauthorized interference or technical failures of any type.

12. Limitations of Liability

By entering this contest, participants acknowledge and agree that Le Québec maritime and the Releasees, as defined in section 7 above, shall not be responsible for, and entrants shall hold them harmless from, any and all claims and damages, including compensatory, direct, incidental, consequential or other damages, liabilities, costs and expenses (hereinafter referred to collectively as "losses") with respect to or in any way arising from or in connection with the contest or related prizes.

Le Québec maritime and the Releasees are not responsible for any losses in connection with (i) incorrect or inaccurate information for any reason, including caused by website users or by any of the equipment or programming associated with or used in the contest or by any technical or human error that may occur in the processing of contest entries; (ii) problems or technical malfunctions of any telephone or telecommunications network, online systems, servers or providers, computer equipment, software, data transmission or email systems, or any other technical problems or traffic congestion; (iii) errors, omissions, interruptions, deletions, defects, delays in operation or transmission, theft or destruction or unauthorized access to, or alteration of, entries; or (iv) damages to entrants or to any other person, including damages to their computer system, related to or resulting from entering, participating or downloading materials in connection with this contest.

For greater certainty, Le Québec maritime is not responsible for lost, late, incomplete, illegible, incomprehensible or misdirected entries, bugs, server failures, hardware or software transmission failures or losses, or delayed or corrupted data transmissions.
